**Food Industry Capacity & Skill Initiative (FICSI)**, a sector Skill Council for Food Processing Industry invites proposals from Maharashtra Based Training Providers/Centres for empanelment with FICSI for providing domain skilling and providing wage employment under Short Term Training (STT) model supported by Maharashtra State Skill Development Society (MSSDS)

The ultimate goal under this STT initiative is to build skilled work force to cater to the specific job requirements of Food Processing industry under the national mission of Skill India. The Organisations/Industry Association can directly partner with FICSI and can build skilled work force as per their domain requirement for meeting their needs.

**The salient features of the STT program under MSSDS:**

- Projects have the provision of train the candidates under the Job Role of “Multiskill Technician (Food Processing) and providing the placements to candidates under Food Processing Industries. For the specific purpose of STT model, employment will mean wage employment.
- The Job Roles identified for this program is Multiskill Technician (Food Processing) - FIC/Q9007
- The candidate enrolment should be as per the capacity of the Training Centre on the relevant online portal and E-KYC would be done for the candidates.
- The Skill Training will be conducted as per the demand generated from Food Processing industries.
- Post completion of the skill training, FICSI will conduct the assessment & certification of the trainees and Skill India certification will be provided to the successful candidates.
- The duration of the programme is till March 31,2024. So, the candidate enrolments will have to be done immediately after the work allocation (if the Training Provider is selected)

**Eligibility Criteria:** The Training Providers complying following criteria may submit their proposal at [tarun@ficsi.in](mailto:tarun@ficsi.in) **maximum by 3<sup>rd</sup> February,2024** in the prescribed format (**Annexure – I**) on the company letterhead with the interest to get empanelment with FICSI for skill training and employment in STT model.

Additionally, the Training Providers will have to provide the required information in prescribed format under **Annexure - II**

There is no fee for Training Providers to submit their Expression of Interests (Eol).

- The Organization should be operational since past 3 years.
- Average revenue of the skill training activities should be minimum Rs 70 Lakh annually.
- The industry should be having well equipped classrooms.
- The company should be having valid PAN, GST.
- The proposed Training Centres (under Annexure – II) must not be pre-occupied for imparting the STT under FICSI or any other sector’s training program and must be available to impart the targets allocated under the Eol.
