Food Industry Capacity & Skill Initiative (FICSI), a sector Skill Council for Food Processing Industry invites proposals from Andhra Pradesh Based Training Providers/Centres for empanelment with FICSI for providing domain skilling and providing wage employment under Recruit-Train Deploy (RTD) model supported by Andhra Pradesh State Skill Development Corporation (APSSDC)

The ultimate goal under this RTD initiative is to build skilled work force to cater to the specific job requirements of Food Processing industry under the national mission of Skill India. The Organisations/Industry Association can directly partner with FICSI and can build skilled work force as per their domain requirement for meeting their needs.

The salient features of the RTD program under APSSDC:

- Projects have the provision of recruiting the candidates and providing the offer letters and then providing Industry relevant induction training before deploying the candidates at their work location. For the specific purpose of RTD model, employment will mean wage employment only.
- The Job Roles identified for this program are mentioned under Annexure – II
- The candidate enrolment should be as per the capacity of the Training Centre on the relevant online portal and E-KYC would be done for the candidates.
- The Skill Training will be conducted as per the demand generated from Food Processing industries.
- Post completion of the skill training, FICSI will conduct the assessment & certification of the trainees and Skill India certification will be provided to the successful candidates.
- The duration of the programme is till March 31,2024. So, the candidate enrolments will have to be done immediately after the work allocation (if the Training Provider is selected)

Eligibility Criteria: The Training Providers complying following criteria may submit their proposal at tarun@ficsi.in **maximum by 26th December,2023** in the prescribed format (**Annexure – I**) on the company letterhead with the interest to get empanelment with FICSI for skill training and employment in RTD model. There is no fee for Training Providers to submit their Expression of Interests (Eol).

- The Organization should be operational since past 3 years.
- Average revenue of the skill training activities should be minimum Rs 70 Lakh annually.
- The industry should be having well equipped classrooms.
- The company should be having valid PAN, GST.
