



OVERVIEW OF INDIAN FOOD PROCESSING INDUSTRY



The Food Processing sector has also emerged as an important segment of the Indian economy in terms of its contribution to GDP, employment and investment.

Overall processing volumes likely to grow at CAGR of 7.5% to reach ~198 MMT in FY'30 from ~96 MMT in FY'20





13.4 Lakhs jobs between FY'20 and FY'30




